## ON-SOLD APPLICATION FORM

Please use this form if you believe you meet all of the following criteria:

1. You are the current owner of the property.
2. You purchased the property within the specified time period. To meet the requirement, you must have:
  - a) made your offer to purchase the property after the natural disaster damage arising from the Canterbury Earthquake Sequence occurred to the property; and
  - b) made your offer to purchase the property on or before 15 August 2019.
3. If your offer was subject to a building condition, you must have satisfied or waived that building condition on or before 15 August 2019.
4. The original owner(s) of the property lodged at least one claim with EQC.
5. Before you made your offer to purchase the property the claim(s) lodged by the original owner(s) to which an ex-gratia payment relates must have already been assessed by EQC and determined to be under-cap.
